#### TRAVEL

Transport will be arranged from your school to and from the University on both days. We'll send out the exact timings in due course, but we expect there to be a morning pick up of approx. 8:00 both mornings, and a drop off of approx. 16:00 on day 1, and 18:00 on day 2.
